FROSTS WHO CLAIM DESCENT FROM (11) THOMAS, SON OF WILLIAM (2).

This descent could not be proven by the compiler, although it is reasonable to suppose that Thomas, son of William the 2nd did not wait thirty-nine years before marrying. However, this line claim their Thomas is buried at Schodack, N. Y., while Thomas No. 11 is buried in the old Frost Cemetery at Oyster Bay. He died 1782, and in his will does not mention any of the children given below, and he certainly should have done so, particularly the son Abial, born as late as 1774. Personally the compiler believes that some future worker on this family will prove that they are descended from the Connecticut family of Frosts and not of William of Oyster Bay, and these facts are published hoping they may be of assistance to some one later on.

In some old letters written by (69) Thomas I. Frost he says his grandfather brought up a boy named Disbrow, who was a relative. Said boy became a prominent man in Westerlo, N. Y., and died over 80 years of age. In another letter he said he often heard his father say that his family came from the town of Northeast, Dutchess County, N. Y., and that his grandfather brought up a boy named John Snyder. One "Snyder" settled on the Manor of "Rensselaer" some years before his

grandfather died and rolled up a log cabin into which his grandfather moved. Another letter states he recalls hearing the old folks talk of Pine Plains, Dover, Pleasant Valley, and Washington, all in Dutchess County, New York. Also writes of some articles in French's Gazeteer of 1860, which the compiler has been unable to find.

ABIAL FROST DEAD.

**PATHTIC END OF A MAN WHO DE
SERVED BETTER.**

**A Pioneer Who Met Hardships With Phil-
osophy and Whose Door was
Always Open.**

On Tuesday morning Abial Frost died at the home of his son John, on the old homestead farm near the village at the advanced age of 79 years. He had been in failing health for some time, but the immediate cause of his death was a stroke of paralysis.

Abial Frost was one of the pioneers of Snyder township, and closely identified with its early history. He was born at Athol, Warren County, N. Y., October 25, 1809. His early life was spent on a farm, but as soon as he was old enough he began working on saw mills, where he soon became a first-class sawyer.

About the year 1834 a member of the firm of Raught & Wilson, who were running a mill where Alonzo Ferman now lives, passed through the section of New York state in which Mr. Frost lived, in search of hands. Mr. Frost hired out to the firm to run the mill for a year, and thus came to Pennsylvania. He remained on Toby for awhile and then returned to New York state where in 1837 he was married to Mary Ann Wilson, of Ticonderoga, N. Y., December 22, 1837.

In the spring of 1838 Mr. Frost returned to Snyder township with his wife, and purchased a tract of land where his farm now is from Dr. A. M. Clarke, and began clearing up a farm. For a time the young couple lived in an old log house that had been built on the premises for a shingle house. At intervals Mr. Frost followed his occupation as a sawyer and ran the mill for Dr. Clarke, chiefly doing the work at nights.

At that time the validity of land titles was very shaky, and after getting his farm from Dr. Clarke, Mr. Frost found that his title was not good, and was obliged to make a new bargain with James W. Guthrie, which likewise proved void. Again a new agreement was made, this time with a man named Vickrey, from whom a legal title was secured. Mr. Frost received no recompense for the land but paid on the first two convey-

Mr. Frost applied his efforts industriously to farming, and it was not long before his energy and thrift began to tell. New buildings were erected, and the clearing became larger and larger as the years went by. The liberal, open-handed hospitality of the hardy farmer and his estimable wife soon became known far and wide, and the house became headquarters for travelers, peddlers, preachers who rode the circuit and newly arrived settlers. The Brians, Robinsons and Holts, of Sugar Hill, as did many others, found a haven of temporary refuge with Abial Frost, while preparing their new homes. The route then from Ridgway to Clearfield ran by the Frost homestead, and scarcely a traveler passed the door where the latch-string was always out without stopping. In this way Mr. and Mrs. Frost gained a large circle of friends.

The house was the scene of many social festivities during the early days of the settlement. Mr. Frost heartily enjoyed the society of his neighbors, both young and old, and was never so happy as when entertaining them. For several seasons the Fourth of July dance, which was a great social event, was held at his barn. It was not the custom then, as now, to dance all night. The festivities began early in the day and ceased at about 9 o'clock in the evening. On such occasions the barn was gaily decorated and a table spread, so that feasting was a feature as well as dancing.

Such was the old-fashioned Fourth of July; and the old Frost barn must awaken many pleasant memories among the remaining gray-haired men and women who were foremost in the sport then, and turn them back to the blossomy long ago "when every sky was blue and every sound a rap-ture of harmony."

Elections and town-meetings were also held at the barn for a time, before the village of Brockwayville had attained any size. Until the first school house was built religious services were often held at the home of Mr. Frost, where the preacher was always a welcome visitor. Father Wray was among those who preached at that early day at the Frost homestead.

On April 1, 1860, Mrs. Frost died. She was a woman of rare accomplishments and refinement, of a gentle and loving disposition which made her universally beloved by all whose good fortune it was to know her. Mrs. Margaret Woodbury—herself a woman of noble traits of character—used to remark that of all the women of her acquaintance three were especially dear to her. These were Mrs. Frost, Mrs. Mary McCurdy and Mrs. James Shaw. Of the four, Mrs. McCurdy alone survives.

About eight years ago Mr. Frost fell from the loft of his barn and received spinal injuries which were thought to have affected his mental faculties, as from that time they gradually became impaired until his reason was almost entirely gone.

When the cloud fell which obscured the old man's intellect darkness lowered upon one of the sharpest wits in Jefferson county. Nature was lavish to Abial Frost in her gift of geniality and humor, as she likewise was with the gift of a ready and pointed tongue. His brilliancy was never of an unkind turn, but always had a tendency to lead men to forget their cares rather than to add to them the pang of a wounded heart, which is too frequently the delight of a man endowed with keen perceptions and ready speech.

Nor was his humor imitative. He was as original as he was keen, and as ready as he was original.

Of him many little anecdotes are related and many of his eccentric remarks are treasured in the minds of the older men.

Eight children were born to Mr. and Mrs. Frost, of whom four are now living. These are Elizabeth, wife of Justus Gage, John W., William H. and Hiram. A daughter, Mrs. Ada Vandervort, died several years ago. The others died in their infancy.

The funeral and burial took place on Thursday, from the old home, and

WAS CIVIL WAR VETERAN

Hiram Abial Frost, one of the oldest best known residents of this section, and a veteran of the Civil War, died at the home of R. K. Marey, with whom he boarded, Tuesday morning of this week, death resulting from a paralytic stroke. Mr. Frost had been at Fredonia a couple of weeks ago attending the wedding of his niece, and stopped off at Kane on his way to Brockwayville to visit his son. He returned to this place Saturday and appeared to be as well as usual. Monday morning he suffered a stroke of paralysis from which he never recovered, death occurring at five o'clock Tuesday morning. The death of Mr. Frost removes one of the best known of the old soldiers of this community who was held in high esteem by all. Having been reared in this community the deceased was associated with the industrial growth of the valley for a long term of years where he was a familiar and influential figure. Mr. Frost has not been actively engaged in any occupation for several years. Six years ago he suffered the first stroke of paralysis and about a year afterwards had another, the latter being more severe than the first and crippled him in such a way that he was incapacitated for work or business, and he had suffered more or less ever since.

The funeral was held yesterday morning at the Episcopal church, conducted by Rev. J. W. Blaisdell. There was a large attendance of relatives and friends at the funeral and many followed the remains to Wildwood cemetery where the last sad rites were performed. The floral tribute was profuse and beautiful. The pall bearers at the funeral were: John Andrews, George Britton, J. A. Adams, L. W. Craft, Joseph Millan and Ira Feit, all war veterans.

Hiram Frost was born at Brockwayville May 11, 1845, on the old Frost homestead above town, and he was the son of Abial and Mary Frost, who came here in the early days and were among the first of the pioneer settlers of this section. Mr. Frost lived here all his life until 1897 when he went to Duhring, Forest county, and lived until a few months ago when he returned to Brockwayville and has since made his home here. Mr. Frost served his country in the Civil war and one of the prominent veterans of this section. He was married to Rhoda Bennett in 1866, and two children were born to them, namely, David E., of Pigeon, Pa., and Eola G., of Fredonia, N. Y. Mrs. Frost died, and several years afterwards Mr. Frost was re-married, his second wife being Annie DeVallance. Seven children were born to this union, namely, William, Lois and Arthur, who preceded their father to the grave, and John, Calvin, Warren and Miss Dora, who survive. Mrs. Frost died in 1896.

With them on their sixty-fifth anniversary were all their six children, all their sixteen grand children but three and their great grandchildren with the exception of one. The children are Mrs. Elizabeth Berg, and Mrs. Peter Dietzen of Fredonia; Mrs. George Moran of Warren, Pa.; Mrs. Mary Frost Popoff of Fredonia; H. Wilson Frost and E. Raymond Frost, of Warren, Pa.

Mr. and Mrs. Frost have resided in Fredonia for the last thirty-eight years and have a wide circle of friends. Mr. Frost was the founder of the Frost Gas company, now the Northwestern New York Gas company. William Henry Frost, the last member of the Frost family, pioneer residents of this section, and one of the finest citizens ever raised in this valley, passed away at his home in Fredonia, N. Y., Thursday afternoon, July 2nd, at 3:30 o'clock. He had been in failing health for the last year and his death was not unexpected.

Mr. Frost was born in Brockway, Pa. November 7, 1843. The Frost homestead west of town, now the home of the W. E. 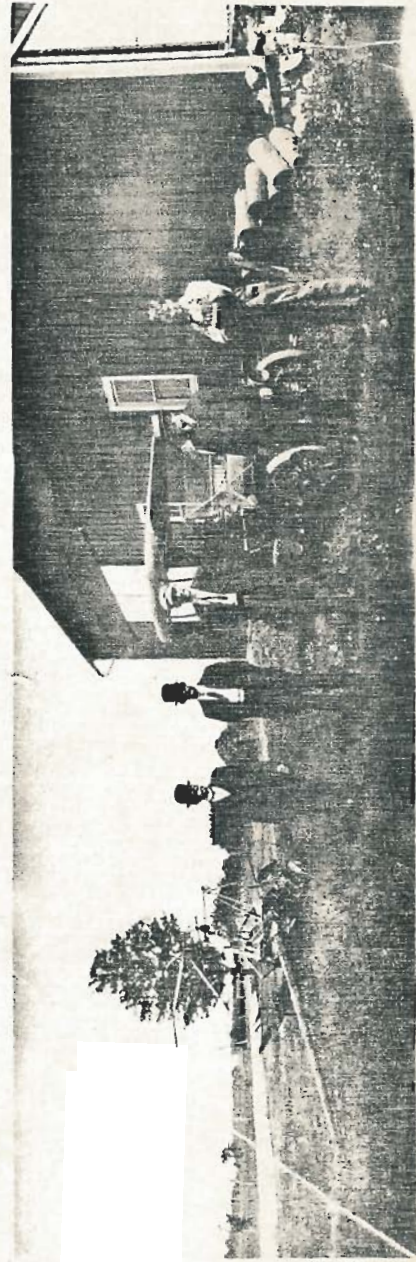

MILL ACCIDENT CAUSED DEATH

Former Brockwayville Young
Man Died in Emergency
Hospital at Warren

INTERMENT AT LEEPER

The death of Arthur Frost, a former well known Brockwayville young man, which occurred at Warren Emergency-Hospital on the first of April, the result of injuries received on a mill at Loleta, mention of which was made in a previous issue of the RECORD, was a misfortune which brought inexpressible grief to the bereaved family and the large circle of friends of the deceased. Mr. Frost was employed on a mill at Loleta and the accident which resulted in his death occurred on February 5th. The injuries were of such serious nature that the young man was taken to Warren and several operations were performed with the hope of saving his life. On the day of his death another operation was performed which consisted of the amputation of the left leg at the hip. The operation was executed in the morning and the patient went through it all right. At four-thirty the same day he took a sinking spell and death resulted in a few minutes. The body was sent to the home of Mr. Frost's father-in-law at Leeper, Clarion county.

The funeral was held Wednesday of last week, services at the Scotch Hill M. E. church, conducted by Rev. L. H. Shingledecker. There was a large attendance of relatives and friends at the church and a large concourse followed the remains to the silent city of the dead at Scotch Hill where the last sad rites were performed and all that was earthly of an excellent young man was tenderly laid to rest to await the resurrection morning. The deceased is survived by his wife and two children; his father, H. A. Frost, of Brockwayville; four brothers, David E., of Pigeon, Pa., J. M., of DuBois, C. H., of Brookville, Warren A., of Kane; and three sisters, Miss Eola, of Pigeon, Pa., Mrs. A. B. Messmer, of Buffalo, and Miss Dora E., of DuBois.

Arthur Frost was born at Brockwayville January 2, 1877. He was educated in the borough's schools and was reared to a life of energy, ability and straightforwardness. Ten years ago he went to Forest county and has made his home in that section ever since, following the occupation of lumberman. At the time of his last misfortune he was employed by the Pennsylvania Lumber Company at Loleta, Elk county, and because of his steady and faithful and cheerful disposition, together with ability and level-headedness, he was considered a valuable employe.

November 29, 1900. Arthur Frost and Miss LeVada Walters, daughter of Mr. and Mrs. E. G. Walters, of Leeper, Clarion county, were united in marriage. Two children were born to them who with the wife and mother survive. Arthur Frost was a man of home and he was happiest when enjoying the pleasant associations of his own fireside. He made no pretence of taking an active part in the din and turmoil of publicity but was content to be a man among men, a man whose first thoughts were of those whom he loved best, a man of honor and stability whose career will help lessen the afflictions of bereavement of those who are left in the garden of earth to fight life's battles.

**DAVID E. FROST IS INSTANTLY
KILLED IN AUTOMOBILE
ACCIDENT**

David E. Frost, aged 64 years, of Pigeon, Forest County, was almost instantly killed in an automobile accident at Riceville Corners, Crawford County, on the McKinney Highway, Thursday morning, August 18, 1932, when the car in which he was riding collided with another car at the road intersection. His granddaughter, Miss Lucile Frost, aged 19 years, of Highland, Elk County, the driver of the Frost car, was injured, but not seriously.

Mr. Frost and his granddaughter were enroute from a visit with his son, Ward Frost, at Jamestown, Pa., Miss Frost being at the wheel of their car, a Buick sedan. The accident occurred at the Riceville intersection on the McKinney Highway as they drove onto the main highway from the side road, their car being hit near the middle by a LaSalle coupe driven by John E. Love, of Corry, a road contractor, who was coming south from the direction of Union City.

Witnesses who saw the crash stated that Mr. Frost was thrown from the door of his car and that Miss Frost was thrown through the wind shield by the force of the collision. Mr. Frost was found to have been terribly injured about the head and chest, expiring soon after he was picked up. Miss Frost was less seriously injured and was rushed to the Union City Hospital, where examination disclosed that she had escaped serious injuries. She was cut and bruised and suffered greatly from shock attending the accident. She was able to be taken to her home at Highland on Saturday. Mr. Love was only slightly injured in the crash. Both cars were badly wrecked. The exact time of the accident was determined by the appearance of Mr. Frost's watch found crushed in his pocket. It had stopped at 9:52.

The death of Mr. Frost was the second to occur at the Riceville intersection this year. The first was on May 5, when Otis Carpenter, of West Virginia, lost his life in an accident similar to that of Thursday.

Deputy Coroner O. H. Danner, of Lincolnville, who investigated the accident, permitted the removal of Mr. Frost's body to a funeral home at Spartansburg, where it was prepared for later transfer to his home. Mr. Danner decided that an inquest was not necessary. He will make a formal request of the Department of Highways to provide further safeguards at that intersection. He will urge the installation of a flasher signal at the west approach, where Mr. Frost and his granddaughter entered the main highway.

David Elisha Frost was a son of Hiram and Rhoda (Bennett) Frost and was born Aug. 29, 1867, at Brockway, Pa. He came to Pigeon at the age of 17 years and had been a continuous resident there since that time. Mr. Frost was engaged in the lumbering business practically all of his lifetime. For many years he was a woods contractor for the Central Pennsylvania Lumber Company. He also owned and personally conducted a large farm at Pigeon and was engaged in stock raising to a large extent. He was one of the most prominent citizens of Forest County, having a wide acquaintance in this and adjoining counties. A man of strictest integrity in all his business affairs, he was held in high esteem by all with whom he came in contact. In 1927 he was elected to the post of County Commissioner of Forest County and served for four years, retiring in January of this year.

About the year 1887 Mr. Frost was united in marriage with Miss Margaret Stahlman, of Fisher, who survives him. Of the six children born to them, five survive, as follows: Chester Frost, of Highland; William Frost, of Pigeon; Mrs. L. R. Strickenberg, of Warren; Ward Frost, of Jamestown, Pa., and Mrs. J. J. Wolfe, of Sheffield. He is also survived by one sister and two brothers, as follows: Miss Eola Frost, of Fredonia, N. Y., John Frost, of Buffalo, N. Y., and Warren Frost, of Los Angeles, California.

Funeral services in his memory were held at three o'clock Sunday afternoon at the family home at Pigeon. The esteem in which Mr. Frost was held was manifested in a great concourse of neighbors, friends and former business associates who came from far and near to pay their last tribute of respect. Upwards of one thousands persons were gathered in the large home and about the grounds. The room in which the body reposed was banked with beautiful flowers, remembrances from relatives and friends.

The services were conducted by the Rev. D. A. Platt, of Clarion, former district superintendent of the M. E. Church, now retired, who was assisted by the Rev. E. J. Jennings, pastor of the Marienville M. E. Church. Interment was made in the cemetery at Pigeon. The burial service was in charge of Acacia Lodge, 633, F. and A. M., of Marienville, of which Mr. Frost was a member, the pall bearers being the following lodge brethren: H. H. Harp, H. G. Sheeley, John H. Fielman, L. H. Measch, W. W. Wilson and James E. Denary, all of Marienville. Mr. Frost was also affiliated with with the Consistory at Coudersport.

SUDDEN DEATH.

Lois Frost Dropped Dead at Her Father's Home on Saturday.

Lois, the oldest daughter of Mr. and Mrs. Hiram Frost, died suddenly on Saturday. She had been as well as usual previous to her death, and had made no complaint of illness whatever. About two o'clock in the afternoon while engaged in some household duties, she stepped to the door and was talking to her mother. Suddenly without warning she fell. Her mother went to her assistance, but she only gasped once or twice and expired. Paralysis of the heart was the cause of her death.

Lois was 13 years old, the 26th of last October. She was a quiet, industrious little girl, always busily engaged in the daily affairs of the household. She was her mother's right hand and an esteemed companion to all her relatives and friends.

The funeral was held at the Baptist church, of which Lois was a devout member of the Sunday school, on Tuesday at 10 o'clock a. m. Rev. Dale, pastor of the Methodist church preached the sermon. The burial took place in the family plot in Wildwood cemetery. The grief-stricken family have the heart-felt sympathy of the community over the loss of their daughter and sister.

MRS. DORA FROST VITT DIED IN BUFFALO

Former Resident of Fredonia Succumbed To An Attack of Influenza—To Be Buried at Forest Hill.

Mrs. Dora Frost Vitt, wife of Harry C. Vitt, died at her home in Buffalo on Sunday night after a brief illness with influenza, which developed into pneumonia. Mrs. Vitt was born in Brockwayville, Pa., thirty-two years ago and prior to her marriage four years ago lived in Fredonia. She was widely known in Dunkirk for two years being society editor of the OBSERVER. She had many friends there and in Fredonia who will sincerely mourn her untimely death.

Besides her husband she is survived by a daughter, Jean, three years old, and a son, born three days ago; four brothers, David Frost, Fredonia, Pa.; John Frost, DuBois, Pa.; C. H. Frost, Virginia, and Warren Frost, Los Angeles, Cal., and one sister, Eola Frost, of Fredonia, with whom for a number of years she made her home.

The body will be brought to Fredonia this Tuesday morning, about 10:30, and will be taken to the Forest Hill cemetery where the service will be held in the church.

DEATH'S CALL. 1896

An Estimable Woman Summoned to Join the Innumerable Throng.

Mrs. Nancy Ann Frost, wife of Hiram A. Frost, died at her home on South street shortly after midnight on Thursday morning. Her death was due to heart disease superinduced by an attack of grip two years ago, which left her in delicate health ever since. The last sickness was of four week's duration.

Before her marriage Mrs. Frost was known as Annie Deyallance among her associates. She was born near Lawsonham, in Clatsop county, on September 27, 1844. Her father dying in her infancy Mrs. Frost lived with her grandfather, Luther Geer, until she grew to womanhood. Mr. Geer lived for a time in Pine Creek township, and afterwards moved to a point near where DuBois is now situated. In her early life Mrs. Frost came to this section which was ever afterward her home.

On October 18, 1875, she was married to Hiram A. Frost, who with five children survives her. Seven children were born to them, but two are dead. Since their marriage Mr. and Mrs. Frost have lived the greater part of the time in Brockwayville. The funeral is to be held on Saturday at 1 o'clock at the Baptist church.

Mrs. Frost was a faithful wife and a devoted mother. Her sphere of usefulness lay in her domestic circle where her absence will ever be regretted. She was greatly esteemed by her neighbors for her many kindly qualities and neighborly virtues. Many years ago she joined the Baptist church and continued her membership with that denomination to the last.

There is one Frost family that is not traced in any genealogy that I have found. JOHN FROST of Rye is well documented. "He is first mentioned in 1684, was townsman in 1697 and supervisor in 1703. He died in or before 1722. In 1718 he paid to Peter Disbrow one hundred and twenty pounds for fifty acres bounded on the north by the highway and field fence in consideration also of the support of his son Abraham during his life and Christian-like burial after his death."¹

In 1693 he witnessed the transfer of the southernmost part of Manursing Island from Jonathan Vowells to Samuel Cdell.² Also in 1693 he was on the Grand Jury at Westchester.³ In 1697 he and Thomas Merritt were chosen to collect the minister's salary.⁴ He was one of the proprietors of the White Plains purchase in 1683, about

the same time that he came to Rye. The lands were finally apportioned in 1720 to forty-one proprietors, all of whom were inhabitants of the town of Rye.⁵

Because John had a son Abraham, Baird thought that he was the son of Abraham Frost of Hempstead. However there is as much or more evidence that he was the son of John Frost of Oyster Bay, for in 1683 John of Oyster Bay sold his house and land, returned a four-acre home lot to the town fathers and appeared for the last time on the tax rolls. In 1684 he, or a person of the same name, is on record in Rye.

Since I have research on both, I will give them equal time.

Abraham Frost (c. 1620-1690) was the son of William of Fairfield, Conn. He was of age at the time of his father's will in January 1644 but if married, had no children then, as all the grandchildren are mentioned in the will.⁶ He bought into the town of Hempstead after his father's death and was there until 1655, when his wife and children were taken captive by the Indians and released near Stamford. He

was in Stamford or Greenwich in 1657⁷ and in Eastchester in 1659.⁸ He was back in Hempstead sometime before 1674.⁹ He is known to have had two children: Isaac, who had Thomas, who married - Oakley - and had numerous descendants in Hempstead;¹⁰ and Mercy, who married John Hendrickson on September 12, 1692, at Hempstead.¹¹ Abraham died before 1693, when Susan Frost, Isaac Frost and John Hendricks sold to John Foster part of fifty acres purchased by Susan Frost's husband, Abraham Frost.¹² *

According to The Frost Genealogy, William and John Frost (c. 1630-1690) came from Sandwich, Mass., with a group that settled Setauket (Brookhaven), Long Island, in 1653. William bought into the town of Setauket and lived there until 1674. John probably lived in Setauket for a while, but he was interested in moving on. His name is on an Indian deed to part of Matinecock Island in Oyster Bay, June 22, 1667.¹³ In 1670 Abigail Frost witnesses

Robert Forman's will.¹⁴ In 1672 John and wife Abigail buy land of Robert Williams.¹⁵ In 1678 John Frost's name appears on a list of freeholders of Oyster Bay. In 1679 a town lot was granted to John Frost and later that year, ten acres of woodland.¹⁶

Josephine C. Frost had some evidence or tradition that John Frost left Oyster Bay and went to New Haven. That he left can be seen from the record: In 1683 he sells to Thomas Miller "a certain house and land, 18 acres be it more or less, housing, fences," etc. Also in 1683 the home lot "formerly laid out to John Frost is given to John Applegate," and 1683 is the last year that he is on the tax list.¹⁶ That he went to New Haven is doubtful. John Frost of New Haven was there in 1665 when he married Mercy Paine, and he died there in 1700. He is obviously not John of Oyster Bay, and he is too old to be his son.¹⁷

William Frost of Oyster Bay, in his will in 1698, specifies that if both his sons die without heirs, the property is to go to any of the Frosts descended from George Frost who was born in Binstead in Hampshire in Old England. I assume this to mean that George was his father and John's and that the descendants referred to are William's grandnephews in Rye.¹⁸*

Born in the 1690's. I find no mention of him except the one in Baird. Unfortunately the early records of Rye are not available. But he seems to be the last of this family there. Later Frosts are all from Long Island.

By 1740 there are two Frost families just over the Westchester line in Putnam County, or Dutchess, as it was then. Putnam was not a separate county until 1812. This is long before any of the Long Island Frosts were in Dutchess and before Jedediah,⁶ who seems to be the first of the Connecticut Frosts, was there. I think these are Abraham's sons.*

I have not found records of either of these.

David, born 1710-1720, was a miller at Carmel. May 10, 1745, the highway commissioners ordered "a highway from Shaw's by marked trees to Frost Mills from thence to Sprage's."⁷ In 1777 David and David Jr. are on the tax rolls.⁸ David Jr. would be the David born 1743. David born 1766 is too young in this case. David's descendants are fully described in The Frost Genealogy.

John born 1710-1720 was living in Dutchess County before 1740, for in that year he had a son there. In the muster rolls for 1760, Capt. Dickenson's Company, is John Frost cordwainer, age twenty, born in Dutchess County.⁹ This is the John Frost listed in the genealogy as #35 John the son of John and supposedly born on Long Island.

On October 11, 1754, the highway commissioners of the South Precinct of Dutchess County ordered a highway to be built "to James Quimby and from thence to Thomas Frost 4 rods wide. One more beginning on the west side of Quimbe farm at the highway from thence between John Frost and James Quimbe farms."¹⁰

In 1755 John Frost signed the call to Rev. Ebenezer Knibloe. The previous minister, John Davenport, was very lax in keeping records. There are some from Knibloe's time, but none relevant.¹¹

Josephine C. Frost says, "John Frost owned a farm one mile north of Croton Falls, Munson Frost says that the old house was pointed out to him by his father as the old homestead."¹² No date on

this, but the location agrees with above information. Much of this area is underneath the Croton Reservoir now. John's descendants are traced.

14. THOMAS

Thomas I believe to be John's brother, since they belonged to the same church and lived one on either side of Quimby's. Also because he seems to have come at the same time, for in the muster rolls for 1760 is Thomas Frost labouror, age seventeen, born in Dutchess County.¹³ He signed the call to Rev. Ebenezer Knibloe, pastor of west soc. of Phillipstown on February 18, 1756. On 28 August 1759 Mr. Knibloe "was dismissed from his charge at Phillips Patent having rec'd a unanimous call from the inhabitants of a society in the Oblong adjacent to Sharon."¹⁴ This congregation was organized in 1749 as "Carmel in the Nine Partners."¹⁵

This is the only Thomas Frost that I have found who by age and location could possibly be the Thomas Sr. who went with his son from Northeast to Renssalaer County in 1788,¹⁶ the Thomas

Frost who appears on the census records for 1790. He must have been born around 1720, when settled territory was not so far from the coast. However I have not so far found records of his travels or of his family. There are several Thomas Frosts enlisted from Dutchess County during the Revolution, and it is possible that both he and his son were veterans. The only sure thing is that in the 1790 census records for Nassau in Renssalaer County there is a Thomas Frost and a Thomas Frost, Jr.

His grandson Thomas Jefferson Frost believed that Thomas Jr. was born in Dutchess County. He said that the family came from the town of Northeast, and he gives two hints that they were descendants of John of Rye: (1) his grandfather brought up a relative, a boy named Disbrow, and (2) he mentions articles in French's Gazateer of 1860. The piece on White Plains mentions John Frost as one of the original proprietors. The other two mentions of people named Frost are Thomas Jr.'s son Abial in Thurman-Athol and a Joel Frost who is son of # 35 John.¹⁷

Thomas's wife was Deborah Stevens (one of the rare times I have a wife's full name). Some of the above are traced in The Frost Genealogy, some not. *

Deborah was the daughter of Nathan Stevens and Phebe Lyon, of Ridgebury, Conn. (Danbury Probate Records Vol 5 pg 352). There is also a bill of sale, "Thomas Frost and Deborah his wife both of Nine Partners in Dutchess Co. N.Y. for 14 pounds to Nathan Stevens, all the land in Ridgefield Dist to Deborah out of estate of her father Nathan Stevens dec'd.

It does seem that Abraham's heirs in Hempstead are not old enough to be the ones captured by the Indians - was Mercy forty when she was first married? - not likely. But except for Nathaniel of Eastchester, whose age cannot be determined, I have not found any fatherless children in this generation.

The will of Ann Graves at Newtown on Long Island, December 31, 1670, was witnessed by Abraham Frost. If this is the same Abraham Frost - and I have no reason to think it is not - he certainly moved around.

Page 5

This is a puzzle. In the New-York Historical Society's Abstract of Wills, "whereas William Frost esq. of Oyster Bay in Queens County, died intestate, letters of administration are granted to his wife Elinor. July 19, 1720." The will in the genealogy appears to be a copy of an earlier will, but where it comes from no one now knows.

Page 6

The Maine Frosts are probably permanently confused because in 1632 one Nicholas Frost was "branded fined and banished for stealing from the Indians and other less pardonable crimes." No one wants to be descended from a criminal; therefore Nicholas has no children. But a close look at the record discovers that whatever his offence he was back within a year and that two of his neighbors gave him gifts of land. Without him there is a definite ancestor shortage in Maine.

If Maine to Long Island seems to be a far cry, we can trace the career of Mr. William Leveridge. In 1633 Gov. Winthrop mentions that he has come to be minister at Portsmouth, New Hampshire. He went from there to Ipswich, Massachusetts; from Ipswich to Sandwich on Cape Cod; and from Sandwich to Oyster Bay on Long Island.

Page 7

It is possible that the home lot laid out to John Frost was to John Jr. on his coming of age. In that case he was born in 1658

Page 8:

This is not as arbitrary as it sounds.
Based on their childrens birth dates, John

and Thomas were born before 1720 which means that their father was born in the 1690s and there is a limited number of men who qualify.

Aside from age there is geography to consider. It was Rye and Stamford people who started the trek up Route 22 to the Adirondacks. If Abraham had decided to leave Rye in the 1730's, this is where you would expect to find him.

There is a controversy here. The will of Thomas Frost (Rensselaer County N.Y. Surrogates Record, File 115, Will Book 6 page 346) lists son Ezra in place of Abial. Descendants of Abial Robinson Frost, Abial's son, believed that their Thomas Frost was their great grandfather. The letter below was copied about 1940. Numbers are "Frost Genealogy" numbers.

(206) EOLA G. FROST HAD A LETTER WRITTEN TO (89) W.H.FROST BY HIS COUSIN (83) DAVID HOAG. THE PART I COPIED IS AS FOLLOWS:

"FEB 10, 1881

SINCE I WROTE YOU I HAVE FOUND RECORDS OF OUR GREAT GRANDFATHER THOMAS FROST AND HIS FAMILY WHICH IS AS FOLLOWS, THOMAS FROST WAS BORN 1747 AT NINE PARTNERS, DUTCHESS CO. AND IN 1788 MOVED TO STEPHANTOWN, RENSSELAER CO. AND BOUGHT A FARM. IN 1806 STEPHANTOWN WAS DIVIDED AND CALLED NASSAU WHICH BROUGHT HIS PLACE ABOUT THE CENTER OF NASSAU. HIS CHILDREN WAS AS FOLLOWS, HIS WIFE DEBORAH FROST (I DONT KNOW HER MAIDEN NAME)

David Hoag was brought up in Thurman when his parents and grandparents were still alive and it does seem that he would know who he was. He certainly

Also the Ezra in the "Frost Genealogy" belongs to some other family as the following paper shows. It was written by one of Ezras grandsons (F.G. # 140)
